- 1. The tender can be purchased from the office of the In charge LSF, Live Stock Farm Adhartal, NDVSU, Jabalpur by paying an amount of Rs.1000/- either in cash or by crossed DD in favour of 'NDPCVV, S/A, LSF." payable at LSF Jabalpur up to 21-03-2024 till 5.00 PM. The tender can also be downloaded from website *www.ndvsu.org*. In latter case, the cost of tender forms of Rs.1000/- should be enclosed in the form of DD along with tender. The tender without tender fees will not be valid and hence it will be rejected.
- 2. - 8. The GST wherever applicable in any items has to be shown separately.
