Candidates shall have to produce all original documents / marks sheet/ grade sheet/ migration/degree/ PDC of all examinations starting from 10th standard to Dean, College of Veterinary Science & A.H., Jabalpur / Director, School of Wildlife Forensic and Health, NDVSU Jabalpur during physical verification. The original certificate of category/ domicile/ EWS /income certificate must also be produced at the time of admission, if applicable.
3. If any candidate fails to produce original certificates, his/her provisional admission will be cancelled and his/her claim for admission will stand forfeited.
4. The fee can be submitted online on any date from the issue of this order up to 15/03/2023 through net banking in following account. Such candidates will have to submit proof of fee payment during physical reporting to the Dean, College of Veterinary Science & A.H., Jabalpur / Director, School of

Wildlife Forensic and Health, NDVSU Jabalpur. Fee can also be submitted through demand draft on the day of physical reporting, for which information is given below.
