Eligible candidates for admission in B.V.Sc. & A.H. and B.F.Sc. degree courses under quota for wards of Kashmiri Migrants and Kashmiri Pandits / Kashmiri Hindu Families (Non-migrants) living in Kashmir valley should carefully read the rules for admission before attending counseling for admission. **Incorrect/false information may lead to cancellation of application form for admission and the candidate will be liable to face legal action.**
2. Admission will be made as per the merit list to be prepared on the basis of marks obtained by candidates in the NEET (UG)-2024 conducted by National Testing Agency (NTA).
3. The prescribed application form for admission may be downloaded from **www.ndvsu.org**  
The 2<sup>nd</sup> counseling under this quota seats will be held at Nanaji Deshmukh Veterinary Science University, Administrative Building, Adhartal, Jabalpur, Madhya Pradesh-482004 (India) on **12<sup>th</sup> November, 2024 (10:00 a.m.)**. **The personal presence of the candidate is essential alongwith the duly filled application form and original documents/ testimonials on the day of counseling as mentioned in Rule No.17 and also proof of application fees of Rs.2000/-, else he/she will not be considered for counseling and admission.**
4. The candidate must have attained 17 years of age on 31<sup>st</sup> December, 2024.
5. The candidate must have passed 12<sup>th</sup> class from a “recognized/ approved Board of School Education having equivalence by Council of Boards of School Education (COBSE), New Delhi/CBSE/ICSE with Physics, Chemistry, Biology and English subjects and obtained minimum 50% marks in science subjects (Physics, Chemistry and Biology) in aggregate.
6. Relaxation in cut-off percentage upto 10% subject to minimum eligibility requirement.
7. The candidates applying under Kashmiri Migrants will have to produce a certificate in the support of their claim issued by Divisional Commissioner/ Relief Commissioner. The domicile certificate is not required for Kashmiri Migrants.
8. Kashmiri Pandits / Kashmiri Hindu Families (Non-migrants) living in Kashmir valley need domicile certificate.
9. No application form for admission will be considered unless it is accompanied by self attested copies of the documents/ testimonials.

Sc. & A.H. programme, the student will refund the total drawn amount of stipend from the college (if any) alongwith a sum of Rs. 1.00 Lakh (one lakh Rupes only) as penalty to get

College Leaving Certificate and Migration Certificate (bond proforma will be made available at the time of admission).
