

Nanaji Deshmukh Veterinary Science University, Jabalpur (M.P.) Master of Fishery Science (M.F.Sc.)

Counseling Programme -2025-26 (Offline/SPOT)

On the basis of the Scores / Rank of AIEEA-PG-2025 Examination of ICAR conducted by National Testing agency, all the eligible candidates can participate in spot / offline counseling for admission (University seats) in post graduate degree programme- M.F.Sc. in College of Fishery Science, Jabalpur under Nanaji Deshmukh Veterinary Science University, Jabalpur (M.P.).

The candidates can participate in spot counseling at Conference Hall, College of Fishery Science, Nanaji Deshmukh Veterinary Science University, Adhartal, Jabalpur as per the schedule shown in **Table 1**.

The domiciles of Madhya Pradesh and candidates of NDVSU, Jabalpur can participate in first round and after up- gradation of the candidates admitted in the first round, all other candidates including other state candidates can participate in the next round of counseling in remaining vacant seats.

NOTE: Academic Session for M.F.Sc. commences from 14th October, 2025.

- Admission to University seats will be strictly on the basis of merit Rank / Score as per the AIEEA-PG- 2025 Examination of ICAR conducted by National Testing agency following the reservation guidelines. In case, the scores of candidates are same, the merit in OGPA of B.F.Sc. will be taken into consideration.
- The detail information, available seats, fees etc. regarding the counseling process is available on the website www.ndvsu.org.
- The admission rules mentioned in AIEEA-PG-2025 Examination of ICAR will be followed.
- The candidates appeared in entrance examination (AIEEA-PG-2025) in Fisheries Science group can only take admission in M.F.Sc. subjects.
- If at any stage it is found that a candidate has taken admission by furnishing wrong information / documents, then the admission of the candidate concerned will be cancelled and action will be taken against such candidate as per the university rules.
- After admission, it will be mandatory for the candidate to report in the allotted subject and college on the prescribed date, failing which, the admission will stand cancelled.
- If a candidate does not take admission in the college after seat allotment, then that candidate will not be eligible to participate in the next round of counseling.
- > Changes can be made in the counseling schedule, the information of which will be available on the website of the University.
- During the counseling process if holiday is declared by Madhya Pradesh Government on the day of counseling, the prescribed counseling process will be completed on the next working day.
- If the required documents (s) in prescribed format is / are not produced by the candidate at the time of document verification, then his / her seat allotment will be cancelled and the candidate will not be able to participate in the next round of counseling.
- Verification of original documents will be done at the time of spot counseling at NDVSU on the prescribed dates.

DOCUMENTS FOR VERIFICATION:

It is mandatory for all candidates to produce the following original documents at the time of Counseling/ Physical Verification:

- > Entrance Examination (NTA) Admit card
- Entrance Examination Mark sheet / Result / Rank Card / Score Card
- > Date of Birth certificate
- ➤ Original mark sheet and certificate of High School (10th) and Higher Secondary (12th)
- ➤ B.F.Sc. degree certificate / PDC mentioning OGPA
- > Character certificate issued by the head of the Institute last attended
- > Transfer Certificate
- > Migration certificate
- > Four recent passport size color photographs on the back of which the candidate will write his / her name.
- > Caste certificate in the prescribed format by the competent authority (if applicable).

- Domicile certificate.
- Economically Weaker Section (EWS) certificate (if applicable).
- > Blood group details and health certificate issued by a registered doctor.
- > Income certificate of parent/guardian (of last financial year) (for reserved category)
- > Aadhar Card
- > Two sets of photocopies of all the above documents
